

# American Amateur Soccer League (AASL) Meeting

## July 10, 2006

### Minutes

Meeting was called to order by Paul Emhoff at 7:30 PM.

#### **Announcements by Paul Emhoff:**

**Mike Globits** – Mike was introduced as one of the two scholarship winners.
